In compliance with the Articles of Association, Mr. Devendra Kumar Agarwal, Director of the Company, chaired the meeting and welcomed 08 Members present. The Chairman thanked the Members for attending and participating in the AGM and declared the meeting as concluded. The meeting **concluded at 04:45 PM (IST)**.
